Summer Course

Digital Justice

June 17th-21st 2019

The Summer Course on Digital Justice (hereinafter: Summer Course) is organized by the University of Palermo's PhD Program on "Human Rights: Evolution, Protection and Limits", in cooperation with the PhD Program on "Legal Pluralisms. Old and contemporary perspectives".

The aim of the 2019 Summer Course on "Digital Justice" is to explore the complex relationships between law and digital technologies. Every day two or three seminars will be held on the most relevant aspects related to technological revolution and on the impact of the ongoing changes for law.

The first day will be dedicated to framing the general theme: from identifying the meaning of the words to a first recognition of the issues in the field. Starting from the second day, we will discuss some of the most important issues related to the impact of technologies on law: human rights, ethics, democracy, markets, adjudication, legal process and law enforcement.

The approach adopted during the Summer Course will always be deeply multidisciplinary and intercultural. Each topic will be discussed from various theoretical and practical perspectives, with the aim of achieving the effective integration of different methods and solutions. In order to encourage active participation, the PhD students will be engaged in a workshop related to the topics discussed in the various sessions, with the support of a recommended bibliography and made available to the participants.

The works will take place in English, Spanish or Italian, depending on the preference of the speakers and the composition of the audience.

METHODOLOGY

The activities of the Summer Course will be divided into daily seminar sessions and in two workshop sessions. In seminar sessions, experts on the subject will hold one or two seminars with an indicative duration of 45 minutes; each intervention will be commented by a discussant, chosen among the PhD students, who will start a debate on the subject of the report. In order to encourage a proactive participation to the activities of the Summer

Course, by the end of May the seminars' summaries will be made available to the members, as well as the bibliographic indications for the study of the topics under discussion.

WORKING LANGUAGES

The working languages will be english, french, spanish and italian.

APPLICANTS, CONDITIONS OF ADMISSION AND CERTIFICATE OF ATTENDANCE

As established by the "Regolamento per l'attivazione di Corsi Internazionali di Studi Avanzati Summer and Winter School" of the University of Palermo, the Course is open to students holding a 1st or 2nd cycle degrees (ita. laurea triennale or laurea specialistica) in the sens of D.M. n. 270/2004, and also to first or second level Master degree students, PhD students, PhD's and researchers.

There are 15 places available, apart from those reserved for the workshop participants and active PhD students. The Summer Course will not be held if there will be less than 15 applications.

Every applicant shall fill in the form here attached, adding his/her CV. If more than 15 applications will be received, the scientific committee will make a selection on the basis of

the *curricula*, and a list of selected students. Students from the reserve list will be contacted if admitted students decide not to participate.

GENERAL INFORMATIONS, CREDITS AND FINAL CERTIFICATE

The Summer Course is composed of two different parts. In the first part, participants have to study the reading material that will be provided on a specific shared folder. Suggested texts (e.g. scientific papers, legal texts, jurisprudential decisions and institutional documents) will be made available at least two weeks before the start of the second phase. The second part of the Course consist in a series of classes by Italian as well as foreing speakers speakers, followed by a discussions and Q&A, based on the lectures and on the reading material. The second part of the Course will be held in Palermo, Italy, at the Dipartimento di Giurisprudenza – Sezione "Diritto e Società" – Piazza Bologni 8, 90143, Palermo, Human Rights classroom, second floor. As the program shows, lectures will be generally held from 9 a.m. to 2 p.m. and from 3 p.m. to 7 p.m. Participants will have full access to the Law department (Dipartimento di Giurisprudenza) Library.

The frequency of the three weeks of the Summer Course, of which two of individual study (based on texts indicated by the teachers and made available to the students) and one of lessons and debates, is suitable to confer a certificate corresponding to 6 ECTS. For this purpose, a final assessment of the learning assessment is foreseen. Furthermore, the achievement of the qualification is subject to the attendance of at least 90% of the scheduled hours.
